# *Main Objectives*



- To provide **information on transport research issues** - for the region of CIS and Black sea countries – regarding the topics of interest to the EUTRAIN project (next slide)
- Identify the potential of the region for (transport) research **capabilities, investment, priorities, and potential** for international cooperation especially with the EU.

# Topics of interest to the workshop



1. Themes for transport research of priority to the countries of the region.
2. Types and current successful examples of international cooperation especially in areas such as:
  - ✓ *Joint programming and governance issues and experiences*
  - ✓ *Common use of transport research infrastructures and their networking possibilities (including information and data sharing issues)*
  - ✓ *Possibilities for harmonizing the training and human resource issues – mobility of researchers and networking*
3. Proposals for further cooperation in the future especially within the new Horizon 2020 framework for research of the EU.

3. Based on your experience from international cooperative research, what are the main factors hindering such cooperation up to now (e.g. funding, programming, research governance issues, lack of information on existing opportunities, human resources, etc, etc)
4. What is your attitude / suggestions towards future research co-operation activities with the EU.
5. Any other relevant issues that each participant may want to raise will be welcome.
